



## 2019 SEASON GOLF PASS APPLICATION

Hillside Country Club is a nine hole public country club in scenic Rehoboth, Mass. A renovation and expansion was started in 2013. There are many amenities on the property that can be enjoyed by all. They include two full service restaurants, one just off the 9<sup>th</sup> hole, the Tiki Bar & Restaurant (open late Apr – early Oct) and an indoor, bar and lounge, La Collina (open year round); full service day spa and salon, Cristallo Spa & Salon; a saltwater heated pool, beach volley ball courts, ceremonial gazebo and our Grand Ballroom available for weddings and other special events. The golf course opens sometime in March (weather permitting) thru early November (weather permitting).

In the fall of 2015, we expanded our irrigation system and began a “beautification” of the course. A golf season pass is just that a pass to play unlimited/ discounted golf with some discounts on some of the other amenities on the property.

A monthly food assessment, April thru October, and the following:

- \*\* Unlimited golf with preferred and or fixed Tee times
- \*\* 10% off golf accessories sold thru the Pro Shop
- \*\* 10% off a pool passes (day & season) & 10% off Spa Treatments at Cristallo Spa
- \*\* Charge card that allows you to charge food, beverage, guest fees, etc.
- \*\* 2 discounted pool passes with reservation privileges
- \*\* Discounted Club Sponsored golf tournaments
- \*\* Balance paid in full – golf free for rest of 2018
